2. FY19 Population Health Report

Mr. Shuckerow reviewed the report with the Trust. The highlights were as follows:

- Medical Loss ratio 75.4%
- Healthy premium surplus of \$2.13M
- Subscribers up by 25 employees
- Average claim up 8.2%
- Cancer is the top diagnosis in the past 12 months
- Shock claims (large claims) up 9%
- June claims up - reason unknown
- Minimal increase in RX claims - 1.8%
- Summarized large claims data, top diagnoses and top RX costs
- Incurred But Not Reported (IBNR) claims at \$415,615
- Dental loss ratio at 81%

3. Financial Overview

- \$9.6M in contributions to the Trust and \$7.7M used
- \$4.3M Trust fund balance
- Anticipated revenue required is \$3.16M

4. Medical and Dental Third Party Administrator (TPA) and Pharmacy Benefit Management (PBM) Request for Proposal (RFP) Discussion

Mr. Shuckerow lead the discussion. Using a TPA allows the city to set a dollar amount on claims review for better claims management. For example, \$5K or \$10K vs. automated claims adjudication in order to potentially save money when claims are managed more closely. In addition, there is more flexibility to carve out the PBM. He is currently working on the timeline and the Request for Proposals (RFP). It is the city's goal to decide by year's end.

5. Clinic Update

Ms. Ruddy presented a brief update on the Goodyear Wellness Clinic. The permanent clinic provider, Danielle Oas, FNP, starts on August 26, 2019.

- Clinic Utilization Summary for June 24, 2019 through July 31, 2019:
 - 92% utilization
 - 215 visits
 - 171 unique individuals (127 employees, 22 spouses, 22 dependent children)
