ACTION REQUESTED

Approval by State Administrator of Resolution No. 0708-0014 - Approving closure of KIPP Bridge College Park.

DISCUSSION

OUSD is committed to operating a dynamic portfolio of schools that meet the needs of the community.

On June 19, 2007, the State Administrator approved the opening of KIPP Bridge Charter School in Fall 2007. This new school will have a comparable program to KIPP Bridge College Park and will be located in West Oakland. Because this new charter school will meet community demand for a comparable program, staff is recommending the closure of KIPP Bridge College Park.

FISCAL IMPACT

The estimated fiscal impact to the district in 2007-2008 will be approximately \$225,000, based on central office costs which cannot be immediately downsized due to the reduction of students (assuming that all students attending KIPP Bridge Charter School would have otherwise attended KIPP Bridge College Park).

RECOMMENDATION

Staff recommends approval for the closure of KIPP Bridge College Park
