ACTION REQUESTED

Approval by the Board of Education of three (3) CL-709 forms recommending approval for Preliminary Education Specialist Teaching Credentials, Resolution No. 1011-0013.

BACKGROUND

The District Intern Certificate Program was enacted in 1983 under a major education reform law. This statute created an alternative route into teaching through District developed and administered teaching internships. The Oakland Practitioner Teacher Program (OPTP) is the Oakland Unified School District's District Internship Program designed specifically for teachers selected and recruited by Oakland Teaching Fellows and similar programs to teach in mild to moderate special education settings. The Oakland Practitioner Teacher Program builds off of the Oakland Teaching Fellows training and program structures, prepares teachers to increase student achievement, and prepares Fellows to succeed in high-need schools in the Oakland Unified School District. The program was developed to create a credentialing program aligned with the needs of first-year special education teachers in high need schools. District Internship program credentials must be approved by the school district's Governing Board in order to participate in this collaboration. Upon completion of all requirements under California Education Code 44328, the Commission awards the Preliminary Credentials to interns upon the recommendation from the school district's Governing Board.

DISCUSSION

Three (3) individuals have successfully completed the requirements of OPTP and are being recommended for Preliminary Education Specialist Teaching Credentials, through the Oakland Practitioner Teacher Program, so they may continue work as Preliminary Credential holders in the District for the 2010-2011 school year. These individuals are being recommended at this time because they have met all requirements of the program, including recently passing a standard assessment only given at certain points in the year. 


