SBX3 4 Tier III Flexibility Acceptance and Uses of Funds

WHEREAS, the enacted 2010/11 California State Budget reduces funding to education by \$1.5 billion; and,

WHEREAS, the enacted 2010/11 California State Budget and SBX3 4, Chapter 12, Statutes of 2009, authorizes school districts to use funding received from the State for Tier III programs, for any educational purpose, to the extent permitted by federal law, for five years from 2008/09 through 2012/13 pursuant to Education Code 42605; and,

WHEREAS, the Superintendent of Schools is recommending that said funds be flexed, accepted and used to meet District education needs as outlined in the Resolve clause below in the amount of **\$39,548,649**,

NOW, THEREFORE, BE IT RESOLVED, upon recommendation of the Superintendent of Schools, the Board of Education hereby accepts and approves for District the use of SBX3 4 Tier III funds as stated below, pursuant to the terms and conditions of the enacted legislation, and, hereby, concurrently incorporates and adopts said funds in the sum of **\$39,548,649**, into and as part of the adopted 2010-2011 District budget as stated below:
