Motion Approving the Fiscal Year 2027 City Commission Priorities - (Commission Districts 1, 2, 3 and 4)

In response to Mayor Trantalis' question regarding updates to the Commission's 2027 Priorities, City Manager Williams outlined two (2) revisions. The first relates to the scope of incentives for business amenity services in neighborhoods, such as grocery stores and dry cleaners, that was expanded to apply citywide.

The second revision relates to the Federal Courthouse and its potential use as a museum to be incorporated into its potential redevelopment. City Manager Williams said staff is awaiting feedback from the United States General Service Administration regarding acceptable use categories. She said that approval of certain uses could make the City eligible for enhanced financial terms, potentially including up to a one hundred percent (100%) discount on acquisition of the federal courthouse.

Commissioner Sorensen made a motion to approve this Agenda item and was seconded by Commissioner Glassman.

Commissioner Sorensen remarked on the success of MicroTransit in the City.

Mayor Trantalis raised concerns regarding Broward County's plan to invest in new buses, questioning the efficiency of such spending given that many buses reportedly operate with low ridership. He suggested that Broward County consider alternative, more flexible transit solutions such as Circuit MicroTransit that is a more cost effective and efficient way to serve residents' transportation needs.

Public Hearing - Quasi-Judicial De Novo Hearing - Consideration of a Motion to Reject, Approve, or Amend the Decision of the Board of Adjustment Denying Variance Requests - Case # PLN-BOA-24040001 - 2436 Cat Cay Lane - (Commission District 4)

Anyone wishing to speak must be sworn in. The Commission will announce any site visits, communications or expert opinions received and make them part of the record.

Two or more members of the Board of Adjustment may be present and participate in the discussion of this item at this meeting.

Each Commission Member disclosed verbal communications, written communications, site visits, and expert opinions received.

In response to Mayor Trantalis' question, City Attorney McCartney explained details of what the Commission Members must determine relative to this appeal.

Mayor Trantalis opened the public hearing.

Mayor Trantalis recognized Ellyn Bogdanoff, Esq., Becker & Poliakoff, P.A., One East Broward Boulevard on behalf of the applicant. Ms. Bogdanoff narrated a presentation entitled *Appeal to the City of Fort Lauderdale Commission February 17, 2026 Agenda Item PH-126-0172 From the Board of Adjustment Tacher PLN-BOA-24040001*.

A copy of the presentation is attached to these Meeting Minutes.

In response to Mayor Trantalis' questions, Ms. Bogdanoff clarified that the shed shown in the upper left-hand corner of the presentation, located on the water side, is rectangular and matches the structure and size originally installed in 2013. She explained that any apparent discrepancy results from the presentation's depiction, not an actual enlargement.

Vice Mayor Herbst questioned inconsistencies in the permit application for the pre-fabricated shed, noting that the document listed the structure as a 10'x10' unit, while evidence suggested it was actually a 10'x20' shed. Vice Mayor Herbst pointed out that the application appeared to be completed in consistent handwriting, raising doubts about whether the size discrepancy was an error or misrepresentation at the time of submission.

Ms. Bogdanoff remarked on the discrepancy but emphasized that the shed had been permitted, inspected, and approved by the City at the time of installation under a prior owner. The current homeowners unknowingly inherited this issue and would have taken corrective action earlier had it been identified during the purchase process. Efforts to correct the issue were complicated by the need for variances, which were not initially obtained by the previous property owner. The current property owners are now facing significant financial hardship due to significant Code Enforcement fines.

Ms. Bogdanoff requested approval of the requested four (4) variances to bring the property into compliance and asked that the accrued fines be waived. In response to Vice Mayor Herbst's question, Ms. Bogdanoff said that there has been no neighborhood opposition and that adjacent property owners have been supportive.

Mayor Trantalis recognized Hudson C. Gill, Esq., Johnson, Anselmo, Murdock, Burke, Piper & Hochman, P.A., on behalf of the City's Board of Adjustment (BOA). In response to Commissioner Sorensen's question, City Attorney McCartney confirmed the City pays for the BOA's outside counsel.

Mr. Gill clarified the Commission's role and the applicable legal standard for evaluating the variance requests. He explained that the burden of proof rests on the applicant, who must demonstrate by a preponderance of the evidence that a qualifying hardship exists under the Unified Land Development Regulations (ULDR).

In response to Mayor Trantalis' question, Mr. Gill explained that the Commission should review the evidence to determine if the applicant meets all required criteria. These include whether special conditions affect the property and prevent reasonable use, whether these conditions are unique to the property, whether strict application of the ULDR would deprive the applicant of rights enjoyed by others in the district, whether the hardship was not self-created or due to ignorance of the code, and whether the requested variance is the minimum necessary and aligns with the intent of the ULDR. Further comment and discussion ensued.

Mayor Trantalis noted there were no members of the BOA present to contradict the facts presented by Ms. Bogdanoff. City Attorney McCartney explained the Commission cannot waive or modify fines. Only the Special Magistrate can waive and modify fines, but the Commission can make a related recommendation.

There being no one else wishing to speak on this item, Commissioner Sorensen made a motion to close the public hearing and was seconded by Commissioner Glassman. Roll call showed AYES: Commissioner Glassman, Commissioner Beasley-Pittman, Commissioner Sorensen, Vice Mayor Herbst, and Mayor Trantalis.

Mayor Trantalis said that the Commission, acting in a quasi-judicial capacity, must determine whether the applicant has satisfied all four (4) required hardship criteria based on the evidence presented, including submitted documents and photographs, and that their decision must be grounded strictly in that evidence.

Commissioner Sorensen said a City permitting error was a key factor that created a unique hardship and moved to approve all four (4) variances, explaining related details, and said that the applicant met the ULDR criteria.

In response to Commissioner Glassman's question about including a recommendation to waive fines in the motion to approve the variances, Commissioner Sorensen suggested addressing fines separately.

In response to Vice Mayor Herbst's questions about input from adjacent neighbors, Ms. Bogdanoff confirmed that one (1) nearby resident had expressed support for the applicant at a prior BOA hearing, explained related information, and said that no written objections or complaints had been filed. Ms. Bogdanoff also noted that a neighboring property had recently changed ownership, and the new owners had not raised concerns.

City Attorney McCartney clarified that if the Commission intended to make any recommendation regarding fines, it would need to be explicitly included in a motion.

Vice Mayor Herbst discussed waiving the accrued fines in conjunction with the variance approval and explained that, while fines can sometimes be reduced or waived, typically "hard costs" associated with enforcement activities such as inspections and staff time are not waived. Further comment and discussion ensued.

Mayor Trantalis concurred with Vice Mayor Herbst's comment that hard costs incurred by the City should not be waived. Further comment and discussion ensued.

Commissioner Sorensen made a motion to approve the four (4) variances, reject the decision of the Board of Adjustment, and

recommended sending this matter back to the Special Magistrate to waive the Code Enforcement fines minus the associated hard costs, and was seconded by Commissioner Glassman.
