Pursuant to the City's Unified Land Development Regulations ("ULDR") Section 47-27., the Applicant held a public participation meeting to present the Project. The public participation meeting was held via Zoom on April 21, 2025. Applicant sent regular mail notice ten (10) days prior to the meeting on April 11, 2025 to all property owners within 300 feet of the Project, notifying them of the date, time and location of the meeting. The Applicant also sent email notice on April 11, 2025 to the presidents of the Poinciana Park Civic Association and Croissant Park Civic Association to share with their membership. A copy of the Public Participation Meeting Notice and Property Owner List/Map is attached as **Exhibit 1**.

There were approximately 15-20 attendees. The Applicant presented the Project and provided an opportunity for Q&A. Q&A followed regarding the nature of the land use plan amendment. Applicant further clarified the existing various land use and zoning designations and the intent to bring the Project into the South RAC boundary to establish a future zoning district for the Broward Health Medical Center campus. Discussion followed regarding the general South RAC code.

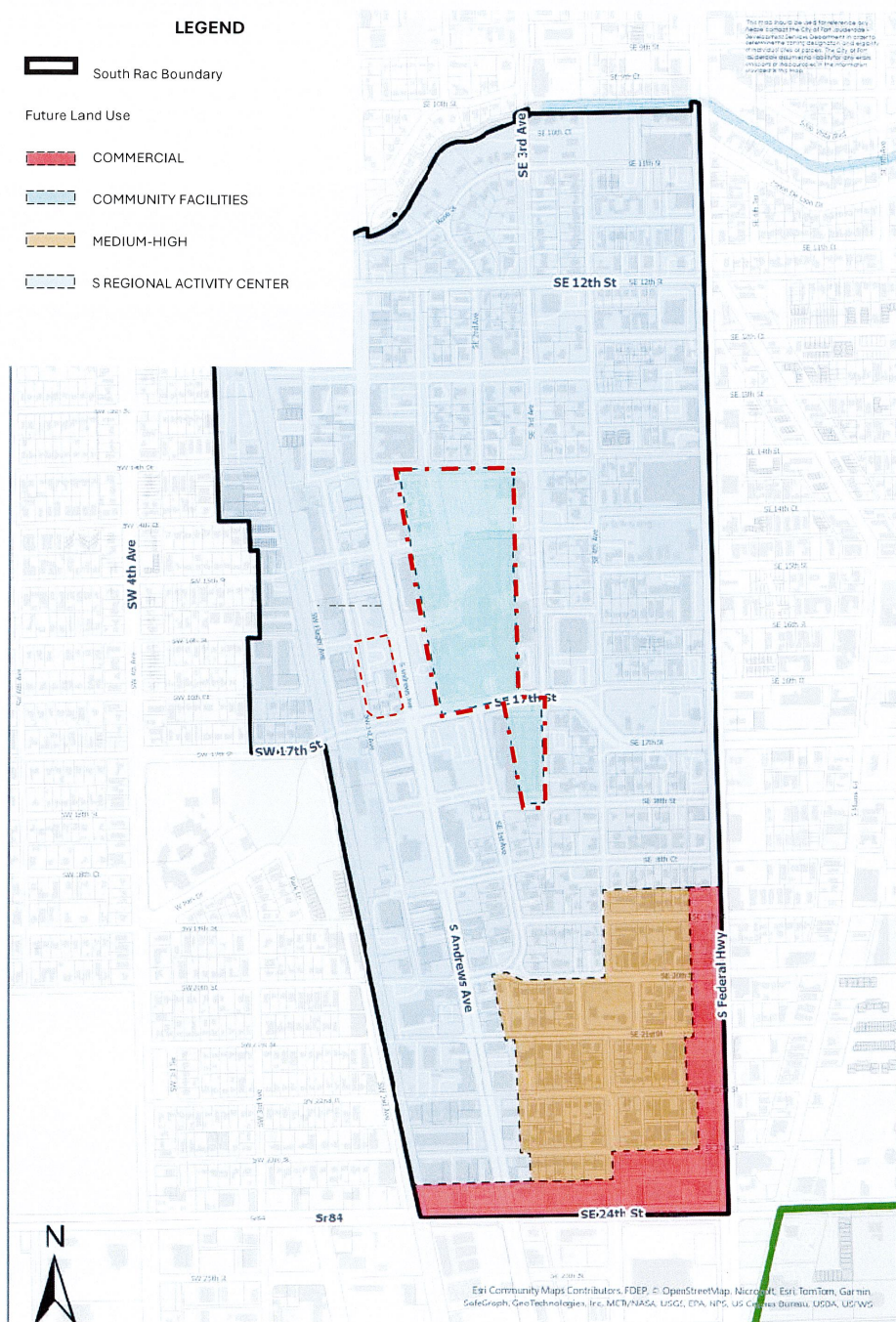

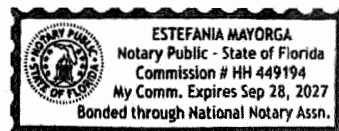
