

RESOLUTION NO. 26-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION, TO THE BROWARD METROPOLITAN PLANNING ORGANIZATION FOR THE ROADS FOR ECONOMIC VITALITY (REV) PROGRAM FOR THE RIVERSIDE PARK MOBILITY PROJECT, AND FOR FUNDING OF UP TO FIVE MILLION DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT APPLICATION AND ANY AND ALL DOCUMENTS NECESSARY OR INCIDENTAL TO THE GRANT APPLICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Broward Metropolitan Planning Organization ("MPO") approved the Roads for Economic Vitality Program (REV) on July 9, 2015; and

WHEREAS, the City of Fort Lauderdale engaged with the Riverside Park neighborhood to develop a scope of work to improve mobility within their neighborhood; and

WHEREAS, the Riverside Park neighborhood identified priorities for implementation that have been utilized to develop the scope consisting of traffic calming and sidewalk installations for this grant application; and

WHEREAS, traffic calming and sidewalk installations are eligible types of projects within the MPO's REV grant program; and

WHEREAS, the Riverside Park Mobility Project ("project") will be evaluated and ranked by the MPO, then vetted to determine programmability in accordance with the REV policies; and

WHEREAS, a resolution from the City of Fort Lauderdale City Commission stating support for the project is required to establish funding eligibility; and

WHEREAS, federally funded projects off the state highway system are delivered using the federally mandated Local Agency Program (LAP) process; and

WHEREAS, if awarded, and accepted, the City of Fort Lauderdale will be required to administer and deliver the project under LAP; and

WHEREAS, the LAP program is reimbursement-based grant program; and

WHEREAS, the LAP requires that the City of Fort Lauderdale advance funding for design, Construction Engineering and Inspection (CEI) services, and construction; and

WHEREAS, if awarded, and accepted, the LAP requires that the City of Fort Lauderdale provide program funding for construction contingency; and

WHEREAS, if awarded, and accepted, the Riverside Park Mobility Project will be constructed within the City of Fort Lauderdale's right of way; and

WHEREAS, if awarded, and accepted, it is the responsibility of the City of Fort Lauderdale to maintain or coordinate the maintenance of the roadways after the project's completion;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA THAT:

SECTION 1. The City Commission of the City of Fort Lauderdale, Florida, hereby authorizes the submittal of a grant application to the Broward Metropolitan Planning Organization for the Roads for Economic Vitality (REV) Program for the Riverside Park Mobility Project, and for funding up to five million dollars.

SECTION 2. The City Manager of the City of Fort Lauderdale, Florida, is hereby authorized to execute the grant application and any and all documents necessary or incidental to the grant application.

SECTION 3. If any clause, section or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby but shall remain in full force and effect.

SECTION 4. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 5. This Resolution shall be in full force and effect upon adoption.
