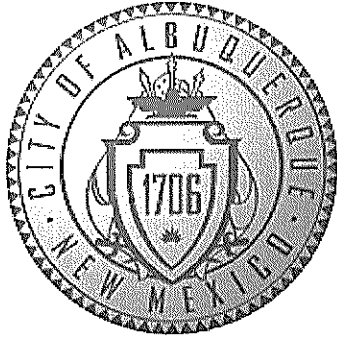

Dara Osher, AICP, is a Senior Transportation Planner with Michael Baker International. She is a member of the American Institute of Certified Planners.

Her project work includes bus network redesigns and transit development plans for Pittsburgh Regional Transit and the Jacksonville Transportation Authority, corridor and complete streets studies in Florida, Texas, and Georgia, and transit research for the Florida and Pennsylvania Departments of Transportation. Her focus areas include transit planning, Mobility as a Service, shared mobility (microtransit and micromobility), active transportation, and traffic safety analysis. She is proficient in Mandarin Chinese.

Osher has served on the APA Florida Editorial Committee, the APA Florida First Coast Section board, and the Capital Region Transportation Planning Agency's Citizens Multimodal Advisory Committee. She received the 2019 Emerging Professional of the Year award from the Women's Transportation Seminar Capital Area Chapter and the 2019 APA Outstanding Student Award.

Osher brings direct transit planning and multimodal policy experience to the Transit Advisory Board.

A resident of Council District 9, Ms. Dara Osher will continue to serve as an At Large Representative on the Board; their second term will expire on September 30, 2029.
