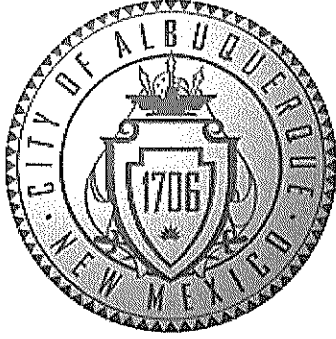

At school, Lauren serves as the 8-9 Division Vice President of the GlamourGals Club, an organization that connects high school students with seniors in assisted living facilities. This past year, she was recognized with a GlamourGals Intergenerational Service Award for her dedication to building relationships each month with senior residents. She has also helped organize school service projects to support families experiencing homelessness and food insecurity, and, for the past two years, has volunteered serving meals at Joy Junction's annual Thanksgiving feast for the hungry. Outside of school and volunteering, Lauren is a competitive cross country and track runner who enjoys running on Albuquerque's public trails and tracks. She is an advocate for animal welfare and her family has adopted two cats from local shelters. Lauren would bring a thoughtful, collaborative, and service-oriented perspective to the Mayor's Youth Advisory Council.

Lauren would welcome the opportunity to serve and hopes to help expand awareness of youth volunteer opportunities, promote the city's youth sports and recreation programs, and advocate for shelter animals and pet adoption throughout Albuquerque.
