It is my pleasure to inform you that your application for a Fiscal Year 2023-24 Beautification Grant has been selected by the Department to receive a grant for your project along US Highway 1 / State Road 5 (Phase I). This grant (Financial Project Number 454232-1-74-01) in the amount of \$210,842 can be used only for the costs allowed by Section 339.2405(11), Florida Statutes.

After receiving your letter of acceptance, Mr. Lockmiller will be available to advise you as you prepare landscape plans for review and approval by the Department. The plans must be consistent with the concept endorsed by the Department in the awarded grant proposal. There is no commitment of funds for the grant project until the Notice to Proceed is issued. Expenditures for work prior to the Notice to Proceed are not reimbursable. Funds will be released by the Department as required by Rule 14-40.023, Florida Administrative Code. Agreements associated with the grant must be executed within one year from the date of the letter of acceptance and meet the requirements of paragraph 14-40.003(3)(c) F.A.C. Failure to execute required agreements will result in the grant award being withdrawn.

RESOLUTION NO. R-2023-292

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND, IF AWARDED, ACCEPT THE FLORIDA BEAUTIFICATION GRANT, AND ENTER INTO A BEAUTIFICATION GRANT, LANDSCAPE CONSTRUCTION, AND MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION.

WHEREAS, many roadside areas and median strips within the Department of Transportation ("DOT") rights of way must be maintained and attractively landscaped; and

WHEREAS, the City desires to beautify and improve various rights of way through landscaping; and

WHEREAS, the City agrees to maintain the landscaped features funded through this program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the appropriate City officials to apply for a Beautification Grant from the Florida Department of Transportation, and if awarded, to accept the grant and enter into a Beautification Grant, Landscape Construction, and Maintenance Memorandum of Agreement with the Florida Department of Transportation.

Section 3: That the City Manager is authorized to accept the funding, if awarded, provided that the City Manager shall have the discretion to refuse the funding in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the funding.

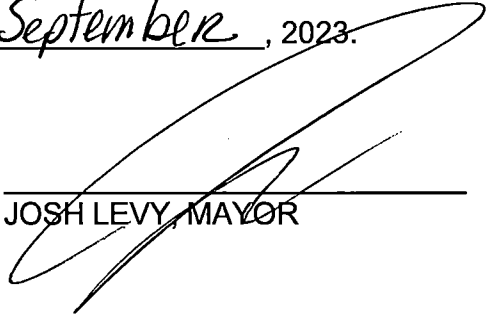
Section 4: That upon funding being awarded to the City, and the City Manager accepting the award, appropriate City officials are authorized to execute all agreements and other applicable documents in a form acceptable to the City Manager and approved as to form by the City Attorney.

Section 5: The City Clerk is directed to send copies of this Resolution to the Department of Transportation and all other persons as directed by the City Commission.

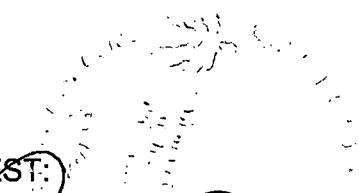
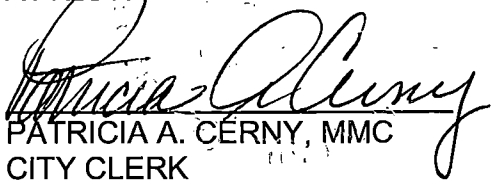
Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.

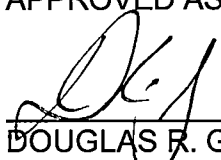
