Hi Dana,

Sorry for the quick follow up email, but reading the design justification one last time, the justification requests the design speed to match the posted speed.

This is not reflected in the typical section package. The Design Speed is shown as 40 compared to a posted speed of 35. If you are looking to reduce the design to the 35 MPH, you would reflect that in both locations, on all 4 typical sections.

Please review one last time and make sure your request/typical section package reflects your end goal.

Also, looks like there is a small gap in the stations/mile posts. Can you updated the exception stations/MPs to match Typical Section No 3, or vice versa?

If you are good with how the package shows the design/posted speed and do not feel you need to adjust it, please let me know and I will hit send on my email to Scott. If you feel we should reduce the design speed, I will hold and wait for the updated package.

Thank you for providing the revised sheets. Some of the comments were addressed but not all of them. I highlighted the remaining ones below. Please make sure ALL comments are addressed this time before resubmitting.

Comments:

- 1.) Confirm if Young Circle is excluded from your grant project limits? The location maps on the Illustrative plans suggests that the first project (FPI 454232-1-74-01) ends at south side of Young Circle and the second project (FPI 454233-1-74-01) starts on the north side of Young Circle. If this is the case, we should adjust the project MP limits on the cover page to match the limits below. **Completed**

454232-1 State Road 5 (US 1) from State Road 824 (Pembroke Road) **(M.P. 1.531)** to (Young Circle) **(M.P. 2.461)** **Completed**

454233-1 State Road 5 (US 1) from (Young Circle) **(M.P. 2.461)** to State Road 822 (Sheridan Street) **(M.P. 4.149)** **Completed**

This would create an **exception area** from:

M.P. 2.461 and ending at **M.P. 2.713**, which would also need to be added to the cover page. **Completed**

Good afternoon, Dana,

I apologize for the delayed response; our team has been coordinating internally with FDOT's In-House Design engineers to obtain feedback on the typical section package you sent over and to review the history of the project. It does look that improvements have been made to the typical section package since it was last submitted, but a few more updates are needed before we submit for official review.

Since our team is new to the grant projects, would you please confirm that Young Circle is not within the limits of either grant project. The Illustrative plans submitted in the application phase do not show Young Circle within the limits of either grant project, but the mileposts that David Lockmiller provided to the city are continuous and do include Young Circle. If Young Circle is not included, we would need to add an exception area to the Typical Section Package. An alternative to the exception, would be to include Young Circle in the Typical Section Package and show the design/post speed for that section of the roundabout. A typical section package must cover the entire project limits.

Our review comments are below. If your team can make these adjustments, we will forward the typical section package and justification statement to Jonathan Overton and Scott Peterson at FDOT for review and approval. After which we can coordinate with your

landscape architect to review the project constraints, based on the new design speed, to guide their design.

Comments:

- 1.) Confirm if Young Circle is excluded from your grant project limits? The location maps on the Illustrative plans suggests that the first project (FPI 454232-1-74-01) ends at south side of Young Circle and the second project (FPI 454233-1-74-01) starts on the north side of Young Circle. If this is the case, we should adjust the project MP limits on the cover page to match the limits below.

454232-1 State Road 5 (US 1) from State Road 824 (Pembroke Road) **(M.P. 1.531)** to (Young Circle) **(M.P. 2.461)**

454233-1 State Road 5 (US 1) from (Young Circle) **(M.P. 2.461)** to State Road 822 (Sheridan Street) **(M.P. 4.149)**

This would create an **exception area** from:

M.P. 2.461 and ending at **M.P. 2.713**, which would also need to be added to the cover page.

Please see the attached cover page mark-up depicting these changes. Please update you Index based on the directions below.

Additionally, the Roadway Section Number should be added to the key sheet, with the County. Revise it to read Broward County (Section Number). Reach out to our team if you need assistance pulling the section number.

- 2.) Please provide each typical section on it's own page. FDOT Design manual requires one typical section and the associated data per page. Ensure all pages are 11x17" size.
- 3.) Please combine the cover page pdf and the typical section pdf into one pdf for submittal.

Once these last few updates have been made, we will submit to Scott Peterson and Johnathan Overton.

As mentioned above, can you also please share your landscape concept plans associated with the grant project so that we can begin reviewing along with the typical section changes. We have only reviewed some general graphic sketches and would like to become more familiar with the proposed project as a whole to better guide you through the process.

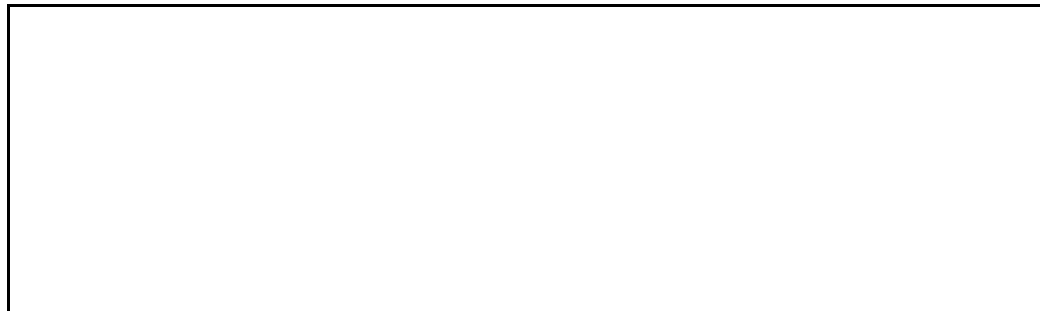
