

PARTICIPATING ADDENDUM
State of Utah

This Participating Addendum (“Addendum”) is made and entered into by and between City of Hollywood, FL (“you”) and Amazon.com Services LLC (“Amazon”) effective as of the latter of the dates this Addendum is signed by the Parties (“Effective Date”).

WHEREAS, the State of Utah (“Utah”) issued a solicitation for an Online Marketplace for the purchases of goods and services in partnership with OMNIA Partners, Public Sector, Inc. (“OMNIA”) on May 22, 2024. Notice of the solicitation was sent to potential offerors, as well as advertised in the following: State of Utah website, OMNIA Partners website, Daily Journal of Commerce in Oregon, Deseret News, Helena Independent Record, The New Jersey Herald, Richmond Times-Dispatch, San Bernardino County Sun, Seattle Daily Journal of Commerce, The State in South Carolina, Times Union, Honolulu Star-Advertiser, Kennebec Journal/Morning Sentinel, Las Vegas Review-Journal/Las Vegas Sun, USA Today, The Advocate – New Orleans, Arizona Business Gazette, The Herald-News. The deadline for proposals was July 10, 2024.

WHEREAS, on May 6, 2025, based on the results of the competitive process, the State of Utah entered into a contract with Amazon.com Services LLC and entitled “Omnia Cooperative Contract – Master Agreement” identified as Amazon Business Contract No. LS4679 (“Contract”).

AGREEMENT

Incorporation: This Addendum fully incorporates the Contract which the parties agree is true and correct.

Term of Addendum: This Addendum is effective as of the Effective Date for a term extending through May 5, 2030 with no renewal options.

Applicable Law: Participating Public Agencies may purchase Products and Services on the same terms, conditions, and pricing as the Lead Public Agency, subject to any applicable local purchasing ordinances and the laws of the State of purchase.
