

RESOLUTION NO. R-2023-237

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AUTHORIZATION TO PROCEED WITH BERMELLO AJAMIL AND PARTNERS INC. FOR LANDSCAPE CONCEPTUAL DESIGN AND VARIANCE REQUEST SUPPORT FOR THE FLORIDA DEPARTMENT OF TRANSPORTATION STATE ROAD 5/US-1 COMPLETE STREETS LOCAL INITIATIVE PROJECT FROM PEMBROKE ROAD TO SHERIDAN STREET IN AN AMOUNT UP TO \$32,920.00.

WHEREAS, the Broward County Metropolitan Planning Organization ("MPO"), the Florida Department of Transportation ("FDOT") and the City are committed to improving alternative modes of transportation and support Complete Streets Corridors providing safe choices to pedestrians, cyclists, transit riders and motorists; and

WHEREAS, the City, together with the Hollywood Community Redevelopment Agency ("CRA"), desire certain additional beautification and landscaping improvements to State Road 5/US-1 to enhance the corridor aesthetic and improve the pedestrian experience; and

WHEREAS, the FDOT eliminated the approved designation for Transportation Design for Livable Communities, which requires a variance request for FDOT consideration to complete the trees and landscaping scope as originally envisioned; and

WHEREAS, on December 19, 2018, the City Commission passed and adopted Resolution No. R-2018-400, authorizing appropriate City officials to execute continuing services agreements to provide professional engineering services for civil, landscape architecture and planning projects; and

WHEREAS, on February 13, 2019, the City executed a Professional Services Agreement for architectural and engineering design services with Bermello Ajamil & Partners Inc. ("Bermello") for miscellaneous projects, and

WHEREAS, landscape design services are necessary to develop conceptual plans of the proposed tree and landscape locations to support the FDOT variance request for the beautification and landscaping improvements to State Road 5/US-1; and

WHEREAS, since the cumulative total contracts that Bermello has been awarded by the City in fiscal year 2023 are currently active and exceed \$100,000.00, as per Section 38.43(F1), Code of Ordinances, City Commission approval is required for subsequent contract awards; and

WHEREAS, DCM and the CRA negotiated the project scope and fee in an amount up to \$32,920.00 with Bermello, and staff has determined that both the project scope and fee are fair and reasonable and in accordance with industry standards; and

WHEREAS, the Director of DCM recommends that the City Commission approve and authorize City officials to execute the attached Authorization to Proceed with Bermello for landscape conceptual design and variance request support for State Road 5/US-1; and

WHEREAS, funding in an amount up to \$19,752.00 is available in account number 334.179901.54100.563030.001361.000.000; and

WHEREAS, the CRA will contribute in an amount up to \$13,168.00 from account number 166.668605.55200.531170.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Authorization to Proceed with the Bermello Ajamil and Partners Inc., together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.

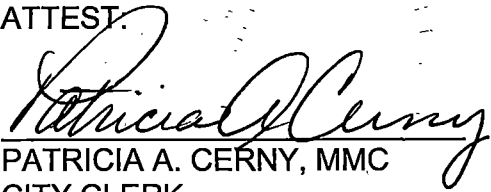
